Clinic Project Gaining Momentum

It's a very exciting time at Grace Cottage, as we work hard to achieve our \$20M fundraising goal for the new clinic project. Thanks to the efforts of Vermont Congresswoman Becca Balint, we were awarded a \$1.5 million appropriation for the project, as part of the FY24 federal budget. When the Congresswoman delivered a ceremonial appropriation check to us in April, she said: "It is so exciting to be able to deliver some hope and help to the area! I know Grace Cottage is such a focal point for so many people in the Route 30 corridor. I talk to so many people when I'm out and about who tell me just how much this hospital means to them. We understand that this makes a big difference, not just for this organization, but for the people who are served by it."

The federal appropriation is one of many gifts that has been received for the project, in addition to a large number of pledges ranging from \$5 million to \$500. In April, an anonymous donor made a \$1,000,000 pledge, and another anonymous donor made a gift of \$100,000; many local businesses and individuals have generously stepped up to help, as have quite a few second homeowners.

"This once-in-a-lifetime project is truly transformational for our community and our patients," said President & CEO Doug DiVello. "In fact, I would go so far as to say that the future of Grace Cottage's primary care practice depends on this building – we just can't continue to provide 31,000 patient visits per year for too much longer in two houses

that were built in the 1840s. These large gifts from the federal government and individuals mean so much to us, but so do the smaller gifts, because they all add up. When people dig deep into their pockets to contribute any gift, no matter what the amount, it brings tears to my eyes because I know that they understand the importance of the new clinic and they are giving what they can to ensure that future generations will get the care they need in this rural area."



In order to provide additional space to meet the ever-increasing demand, the Rehab Department will be relocating to the Heins Building by the end of the year (the large white house with black shutters located next to the hospital driveway on Route 35). In order to make this possible, extensive renovations will be made to the interior of the Heins building by Brunelle & Son this summer and fall. After the Outpatient Rehab department has been moved into the Heins Building, the Grace Cottage Foundation, Human





Want to Lower Your Taxes?

If you have a traditional IRA and are age 70½ or older, you are eligible for a special tax benefit: giving a Qualified Charitable Distribution (QCD) from your IRA to a charity such as Grace Cottage, tax-free.

While withdrawals from traditional IRAs are taxable income, QCDs are not and can satisfy some or all of your annual required minimum distribution (RMD) if you're age 73 or older. But reducing your account before you are required to take distributions can mean paying less in taxes later on. OCDs can also be used whether you take the standard deduction or itemize deductions.



You may also direct a one-time Qualified Charitable Distribution to a charitable remainder trust or charitable gift annuity as part of recently passed federal SECURE Act 2.0 legislation. Either of these will generate annual income for you, and interest rates are very favorable for charitable gift annuities at this time. For example, the fixed rate for a single-life Charitable Gift Annuity for someone who is 75 years old is 7%, and 8.1% for age 80. The minimum amount for a Charitable Gift Annuity at Grace Cottage is \$10,000, and it's an easy one-page document to fill out and sign. Payments from Grace Cottage to charitable annuitants are made quarterly, and are usually direct-deposited into the annuitant's checking or savings account.

Ask your financial advisor or tax consultant about how you can help Grace Cottage and yourself at the same time.

Grace Cottage was recently notified of a generous bequest from Alexandria Bosna (also known as Sandy and Sandra).

Born in North Bergen Township, New Jersey, in 1939, Sandy went to Glassboro State College (now Rowan University) and graduated with a Bachelor's Degree in Education. After teaching in a public school, she joined her parents, who were living in Italy at the time, and taught at a U.S. military base. Upon her return to the U.S., she began a career with the New Jersey Department of Human Services' Aging Services, where she remained until retirement in 2002.

Sandra and her life partner, George Rosenthal, met in 1975 and made Winhall, VT their second home in 1999, supporting the community as volunteers at the Bondville Fair, delivering Meals on Wheels, and exploring Vermont until George's passing at Grace Cottage Hospital in 2018. Sandy died at Grace Cottage on November 21, 2023. She is greatly missed, but she has left a wonderful legacy, remembering not just Grace Cottage, but other non-profit organizations in Vermont as well.

High-Tech Diagnostic Imaging Services at Grace Cottage

Perhaps because it's behind closed doors, Grace Cottage's best-kept secret is that we have an excellent Diagnostic Imaging Department, with nine radiologic technologists, and an ultrasound technologist on staff or on call. We hope you never "meet" any of this equipment, but it's nice to know it's here if you need it!



Our Philips CT scanner was recently upgraded to 128 slices (to put this into perspective, our first CT scanner, acquired in 2012, was 4 slices!).



In early 2024, we upgraded our X-ray room and machine to a state-of-the-art facility.



Our portable X-ray is used for patients who aren't able to be moved from the Emergency Department or from inpatient beds.



Grace Cottage's ultrasound machine is used to help diagnose the causes of pain, swelling, and infection in the body's internal organs.



Our portable ultrasound machine is used primarily in the Emergency Department.
